Our All-Star Holiday Revue Champagne Buffet Gala Fund Raiser with the Unitarian Church in December was a unique and entertaining affair. We even made money. During 1993 we performed several times for the O. Henry Museum, as well as in February for the University Ladies Club at the Westwood Country Club. Our monthly Musicales at the accommodating home of Pearl Amster are becoming ever more popular. Happily our membership list keeps expanding.

Now we again look to the future. And for me the future scarcely reaches beyond Pinafore.

I promise a first-rate production. But financially, I don't know. We obviously have not yet mastered the art of securing corporate sponsorship. Therefore we still must depend on the generosity of individual members and supporters to help defray production costs. Please keep those checks coming in. Incidentally we're working on ideas to demonstrate our appreciation to contributors.

I do wish everyone a Happy New Year, and join me in wishing success for our Gilbert and Sullivan Society.

There was objection to the wording of one amendment. [This was later reworded by Allen Lawshae; the amendments will be found on page 3 of this Newsletter.] We discussed ideas for publicity for *H.M.S. Pinafore*. Harold Gilbert sang "A more humane Mikado" from memory, unaccompanied, and departed for the *Pinafore* rehearsal.

Robert reported on the Fund Raiser. The program went off well, we made some money (and so did the Unitarian Church), but the food was a disaster. Pearl said she would never do a joint food project again. It just did't work. Charging two prices (\$25 for the Champagne Buffet and front row seats; \$10 for open seating farther back with no champagne) seemed to have been a good idea, although it had its awkward moments. Families were able to buy \$10 tickets when paying \$25 each for four or more people would have been too much. Another benefit from the Fund Raiser was tapping into the Unitarian Church membership and adding a new group of names to our mailing list.

Bill Hatcher presented the slate of officers, and sang his version of "A more humane Mikado", also unaccompanied and from memory. Robert reported the donation from American Airlines of two round-trip tickets on their airline. In order to realize any money from this gift we have to sell chances for the tickets, raffle them off, or run an auction. Loel sang "There lived a king" from *Gondoliers*, ending with that gem of wisdom "When everyone is somebodee, Then no one's anybody". Robert brought things to a fitting conclusion by singing "Now to the banquet we press" to usher us on to refreshments. These sturdy souls are much to be commended for providing the music for our score-less and piano-less evening.

President Robert brought us up to date on the many on-going items of production for *H.M.S. Pinafore*. Concerns include need for money, piano, insurance, photographer, posters, and flyers. Other problems are how to get the greatest benefit from the gift of airline tickets from American Airlines, and how to plan the Gala Opening Night for *Pinafore*. Should we do it ourselves? More work for Pearl and contributed food from members. Or should we cater? Easier, but more expensive, and often not as tasty. Part will come from the 10% surcharge paid by the customer, but the Society will make up any difference in the overall fee. #### Amendment # 1

Section 7 of the bylaws currently reads as follows:

The Executive Board (or Board of Directors) shall consist of all elected officers of the Society. It shall carry on the day-to-day business of the Society between meetings of the membership, and shall report its activities at the next membership meeting of the Society. It shall meet upon call of the President or any three officers. Actions of the Executive Board must be approved by a majority of the total Executive Board.

A second paragraph shall be added to Section 7 which will read as follows:

The Executive Board has discretionary power to select up to three members of the Society to serve as Directors at large on the Executive Board. They shall be appointed annually, their terms not to exceed the terms of the appointing Board.

[Note: This is a revision of the amendment presented to the December 13th meeting of the Society. It was rewritten to satisfy the concerns raised at that meeting.]

#### Amendment # 2

An additional Section shall be added to the bylaws between Sections 7 and 8. It will appear as indicated below:


#### Section 7a. Advisory Board

The Advisory Board shall consist of persons elected by the Executive Board in recognition of their service to and support of the Society. They shall serve as consultants to the Executive Board. Their terms of office shall be two years.
