Future of The Society

By your Board of Directors

As many of you may know, for the past several months **Allan Longacre**, retired from a long career in arts administration, has been conducting a review of The Gilbert & Sullivan Society, including many interviews with members and performers. He presented his Report to the Board on December 13, 1999, and we extensively reviewed it at our meeting of January 10, 2000. Here is a summary:

The Gilbert and Sullivan Society serves its members, who are dedicated to the enjoyment and preservation of the works of Gilbert and Sullivan. Another way to describe The Gilbert and Sullivan Society would be to say it is a "club," with all the problems of a club. That is: "not all of the members are as dedicated as they ought to be," "only a few members do all the work," "the person who is willing to do all of the work ends up with all the power," etc.

Recognizing this to be a normal condition for most volunteer organizations, The Gilbert and Sullivan Society is just fine. It has

weathered a difficult situation and seems to be on its way to continue to serve its members and achieve its purpose. There is much good feeling throughout the community toward the organization and its members. Therefore, my major recommendation is to keep on "keeping on." For the immediate future, that means one major production a year, monthly musicales, a newsletter, and outreach through in-school performances.

The G&S Society has three components, which could almost be considered three different organizations, each with different and probably often conflicting needs and purposes. These are:

- 1) The membership those who pay dues, go to the musicales and performances, receive the newsletter, and in some cases also volunteer.
 - 2) The performers, musicians, and technicians those who (continued on page 2)

Preview of Topsy-Turvy

Last Musicale

On Tuesday, January 25, 2000, at 7 pm a happy crowd gathered at the Arbor 7 movie theater for a free preview of *Topsy-Turvy*, the new film about Gilbert and Sullivan. President Larry Shepley and Executive Vice President Libby Weed sat at a table in the lobby to hand out the free passes, and give out information about our Society. Later we were told that the ticket taker at the door had admitted around three hundred people. These were mostly, but not all Society members: Larry had invited the members of the UT adult group LAMP to attend, and a local Film Society had also invited their friends and members. We have a tentative list of people who called the G&S office for tickets, and some who showed up at the door, but many people did not check in at the table. Some people were seen by one member but not by others, and we haven't tried to compile a list of those present.

We all enjoyed the film thoroughly, and hardly noticed that it was very long. The music was delightful, although there were some complaints about a faulty sound track. The picture of Victorian London, and the very different lifestyles of the two main characters (Gilbert and Sullivan, of course) was very interesting and colorfully presented. As noted in reviews, the main body of

put on the annual productions, the musicales, and the in-school performances.

3) The Board of Directors — those ten individuals who worry about all and do most of the work associated with the activities, finances, and policies of the organization.

However, many members recognize that there are four areas that threaten the survival of The Society. They are:

- 1) The membership is aging. If the organization continues as it has, in another decade or so the majority of its members will be unable to participate.
- 2) The board members find themselves expected to do most of the work of the organization that cannot be contracted out to paid individuals or organizations.
- 3) The organization is at or just past the point of development where its members and participants can be confused about its direction and future. Misunderstandings and disagreements can easily lead to conflict.
- 4) The Society, for a non-profit organization, has been financially solid, or at least, it has that reputation. Members and participants have expressed an almost "smugness" about being solvent. When the reality of the costs of running the organization become apparent, the Society's ability to continue could be at risk.

In response to this analysis of the situation the Board voted:

1) To hire a paid manager or coordinator to oversee on behalf

the film concerned the process of producing *The Mikado*, with great attention to detail and some surprising revelations. To answer the question raised by quite a few people, it appears that the movie was on the whole quite accurate in its depiction of individual characters. It is a commentary on the different standards of that day and ours that many viewers commented that our 1998 *Mikado* had been a really much better production! Well, after all, a cast of ladies used to wearing corsets but asked to move in the fluid Japanese style might have had a long way to go to achieve Gilbert's goals.

Afterward 15 of us assembled informally at the coffee shop in the Barnes & Noble Bookstore next door. They were members Lucian Chimene, Len & Reba Gillman, John & Carolyn Gregory, Allen Lawshae & Kay Novak, Michel & Majorie Saad & friend, Steve & Eve Schwartzman, Larry Shepley, David Tampke & friend, and Libby Weed. In addition two other couples were there but did not join the larger group: Joan Piersall & Carla Cerisa, and Sue Gordon & friend. As a variation on the usual G&S Musicale this was a very successful event.

Note: *Topsy-Turvy* is just entering its third week at the Arbor 7. If you want to catch it again, or for the first time, it would be worth checking the papers, or calling the theater, to see if it is held over still longer. After all, the film did receive four Oscar nominations.

of the Board of Directors the ongoing business of the Society and the office worker (who might be an Arts Intern). This person's responsibilities will include oversight of those in charge of the Musicales, annual productions, in-school programs, the performing ensemble mentioned below, and any committees we establish. We agreed with Allan's recommendation that we not use the title of Executive Director for this person, since this title might imply artistic and administrative power over an organization that at present operates successfully as a club. We also agreed with his assessment that a paid coordinator or manager would better serve the organization by keeping its three components focused and moving forward cooperatively

- 2) To form a small ensemble, which we would pay, to perform in schools and other community outreach activities. These performers might serve as a core group for major productions and could perform at Musicales and Galas.
- 3) To establish the following committees: Finance or Fund Raising; Publicity; and Volunteer Coordination. Of course we will make specific what we are asking members to do (make coffee, clean up, etc.), and we will certainly thank volunteers in the Newsletter and the show Playbill.
- 4) That the Board, with input from the membership, should create and publish short and long range goals for the Society.
- That the Society should make a greater effort to attract young members.

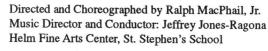
