Reba made announcements: 1) a program of compositions by Andrew Hallock was to take place Wednesday April 10 at 5:30 pm in Bates Recital Hall at UT; 2) the Tribute to Jess Walters by the UT Voice Faculty was to take place on Saturday April 13 at 8 pm in Jessen Auditorium at UT; 3) the next Musicale would be on Monday, May 6, at 7:30 pm at Paula's (the Armstrong Community Music School is saving money these days by not opening their building on Sundays); 4) the next Board Meeting would take place on Monday, May 13, 2002 at Paula's.

Jean Smootz begged for volunteers to help with a large mailing coming up to inform schools about our program, *Pirates in School*. Clydene offered to help

Bee Palomé announced that the annual Pearl Amster Concerto Competition would present a concert on Saturday April 6 of the three young winners playing with the Austin Civic Orchestra, and urged us to attend.

President Larry Shepley announced the cast for our June production of *Trial by Jury* (see his message on page 1). The Usher will be played by Bob Nelson, who is an old friend and played the Usher in our earlier productions of *Trial* as well as the Sergeant of Police in our last production of *Pirates*. G'ann Boyd will be the Stage Director; Cheryl Borden will be the Production Manager; Art DiBianca will be Lord High Everything Else; Jeffrey Jones-Ragona will be the Music Director; and Andrew Hallock will be the Assistant Music Director.

To round out the evening there will be scenes from G&S, songs by Sullivan, and at least one Bab Ballad, presented by Gary Hallock. Janette Jones will do the Mad Margaret scene from *Ruddigore*, and there will be a couple of trios from *Princess Ida*.

The evening's program then began as Faith DeBow entered dressed in a charming Victorian costume and proceeded to play the piano prelude of three pieces from 1915. Leslie then came in, also in costume, and welcomed us to the journey down memory lane: "If you hear any songs that you recognize you are certainly invited to sing along!"

There followed a beautifully sung and played series of songs from the early 1900s, with Leslie's helpful comments interspersed. I noticed that the audience joined in happily on several of the songs. As the evening progressed Leslie introduced her

brother and his wife (Marshall and Shannon Nay), and finally dedicated the last song to her sisters-in-law Carmen and Paula Tyler, "to tell them how much I love them," and to thank Paula for opening her home so generously to The Gilbert & Sullivan Society. I later confirmed that the relationship was that Ron Tyler married Paula, and his brother Richard married Carmen Salas, whose brother Richard Michael Salas married Leslie Nay.

As Leslie and Faith ended their program Larry asked that Faith accompany while all joined in singing the customary "Hail Poetry" from *Pirates* and "Now to the banquet we press," from *Sorcerer*. It was a truly wonderful evening!

The program ended with a magnificient scene between Germont and Violetta from Act II of *La Traviata*, sung by Darlene Wiley and David Small. An enthusiastic audience loved every minute of the evening. Note: We missed Rose Taylor, mezzo-soprano, who was not able to participate because she was singing in Dublin.
