## The By-Laws Committee

We have been working hard on constructing new, appropriate, and legal Bylaws. The most important change is that by Texas law, a non-profit, membership organization must elect a Board of Directors. Sue Caldwell did a magnificent job on a first draft and met with other members of the Executive Board to refine the document. A final version will be available at our annual meeting in January. Copies of the document will be on hand at 7 pm for members to review and discuss. The formal meeting will begin at 7:30 pm as usual and will take place at Paula Tyler's house.

### Message from Your President

Please watch for the next Newsletter. In it there will be important news about our Bylaws. Our present Bylaws do not reflect what we are doing, but more important they are not in agreement with legal requirements for a membership organization such as ours. We will be devoting our Annual Meeting on January 6 to this matter, and we would like you to participate. One important procedural matter has to do with the election of officers, which is usually the main agenda item of the January meeting. Of course, whatever reorganization may occur, we will still be a Society which is based on you, our Members, and which is devoted to bringing to Central Texas the most enjoyable musical theater ever written — the operas of Gilbert & Sullivan!

I have been guilty of telling people that *The Grand Duke* deserves its obscurity, but Len Gillman has complained that I am unnecessarily negative about it. After all, as Len says, to say that it is not up to the standards of, say, *The Pirates of Penzance*, is hardly much of a criticism; neither is *Cats*. Len suggested that I would be better off saying simply that *The Grand Duke* was the least successful G&S opera — "after all, one of them has to come out last." Well, I agree that *The Grand Duke* is last, but I also agree that I shouldn't downplay a production I enjoyed as much as I did.

I have a recording of *The Grand Duke*, with all the music (but not the dialog), and I think our version is better. Brad Merrell and Art DiBianca had to reduce the length of the opera because Westminster Manor felt that a short concert version would be better for that venue. The result, however, is a nice, pleasant, lively opera, with just enough stage business — again, due to Brad and Art. I find myself humming the songs and smiling over remembered parts, much more than I ever did after listening to the full version. Len, who, let's face it, can be a somewhat severe critic, thinks that we should publish Brad and Art's version I'll let you know if we do.

In other news, we are applying for grants and donations — please, if you have ideas, let us know. We will also be stepping up our publicity efforts, so look for us and listen for us. Would you like to help? Please contact me!

#### Last Musicale

Our November production of a concert version of The Grand Duke or, The Statutory Duel, edited and produced by Brad Merrell, Arthur DiBianca, and Larry Shepley, was a great success. Brad and Art did a wonderful job of cutting and condensing to achieve an efficient version of the very complicated plot. They had to omit some of the music, but chose very wisely and left in the best parts. Their cast of 13 singers sang well, using music and wearing a variety of identifying hats. I particularly enjoyed the performances of a visiting newcomer to our ranks, Larry Garvin. He undertook to sing the parts of the Grand Duke and also the Prince of Monte Carlo. The latter appears only in the final scenes but is a wonderful, French-accented, patter-singing character, with the catchiest song of the whole opera. Everyone did a fine job, but our former President Libby Weed distinguished herself as a loud-mouthed and unpleasant Baroness von Krakenfeldt — a real acting accomplishment!

The two performances at Westminster Manor (Monday November 4 and Thursday November 7), were well attended but not uncomfortably crowded, and everyone seemed to have a good time. Thanks to Jean Smootz, who helped out by selling tickets on November 4, and Terri Wilson, who sold tickets on November 7. I was there both days and sold a few G&S items during the intermission. President Larry Shepley was everywhere, making announcements, tending to little problems, and playing the flute (although not very much this time). Andrew Hallock was a fine Music Director, and accompanist Gloria Kim was excellent, cheerful, and reliable. Gary Hallock served as Master of Ceremony, as he does so well, explaining the action and setting the scenes. We agreed that Westminster Manor is well suited to this kind of production and that we should do this every year. Two performances seemed more comfortable than only one.

Finally, it should be said that we actually cleared a modest profit on this production. Residents of Westminster Manor were admitted free, but others were charged \$5.00 admission. Costs were low, and the three producers contributed to support the event.


